NB. If no Capitation Fees are paid the fee for registration of a heifer calf or a late registration will be £35 + VAT.

It is recommended that all herds with 20 or more breeding females become members of the Signet Beef Breeder Scheme. For more information contact the Society Office.

All heifer calves listed on Birth Returns will automatically be entered for registration in the Society Herd Book and named according to the dam line. This does not prejudice the prerogative of the breeder to withhold registration and such a decision must be notified to the Office prior to the compilation of the current Herd Book.

Bull registrations should be applied for separately, subject to current Society Rules.
