RETURN OF ALL BREEDING FEMALES DUE TO CALVE IN **2026**

[Applies to all cows due to calve animals eligible for registration in all sections of the Society's Herd Book]

NB. If no Capitation Fees are paid the fees for registration of females will be applied. The minimum fee is £40 +VAT for heifers under 12 months old.

Bull registrations should be applied for separately, subject to current Society Rules.

It is strongly recommended that all herds with 20 or more breeding females become members of the Signet Beef Breeder Scheme. This is a free service from the Society available to all breeders who pay their Capitation Fees by 31st March.
